## For PART-TIME Ph.D. DEGREE

- (i) Part time candidates who seek permission to register for Ph.D. should enclose Service Certificate issued by the Head of the Institution indicating the nature of appointment (Permanent or probation or temporary etc.), date of appointment etc.
- (ii) Higher Secondary School Teachers (High School / Polytechnic) working in the recognized Higher Secondary Schools (High School / Polytechnic) (within the Periyar University Area) alone are eligible for Part-Time Ph.D. Registration. Along with the application, the following Certificates are also to be enclosed:
  - 1. A Certificate from the District Educational Officer DTE stating that School, Polytechnic has been recognized by the Government to conduct Higher Secondary (+2) Course, Diploma Courses.
  - 2. A Certificate from the Headmaster / Headmistress / Principal of the School, Polytechnic where you are employed stating that you are handling classes for Higher Secondary (+2) Students, Diploma Courses and also a Service Certificate indicating the date of appointment, nature of appointment (i.e. whether Permanent or temporary or leave vacancy etc.)
- (iii) Guide approval copy
- (iv) 10th, +2, UG, PG, M.Phil degree certificate attested copies, mark statement and Lecturer Qualification Approval copy.
